The Clerk Administrator read the comment from the Ministry of Transportation (MTO) and advised the Consultant Planner is recommending Council defer passing the temporary zoning by-law amendment until the applicant has applied for a pre-consultation with MTO.

The proposed amendment has been requested by the owner of lands located in Part Lot 32, Concession 14, known as 11077 Highway 124, in the Township of Strong. The purpose of the proposed zoning amendment is to zone the subject lands to recognize the existing land use (Crystal Cave) in a General Industrial (M1) Zone on a temporary basis. The applicant/owner has established a commercial establishment consisting of mineral, gem and fossil exhibits, a retail shop and gallery as well as facilities for artisan education. The current land use is not a permitted use in the Township's General Industrial (M1) Zoning and therefore the owner has applied for a temporary use which would legalize the use for up to three years while they prepare the requisite technical work and studies to support an application for permanent zoning.

James Toth, Julia and John Breckinridge provided a brief overview of the property and proposed amendment.

Council raised no questions on the proposed amendment. They recommended the applicants get in touch with the Almaguin Community Economic Development Director to inquire about funding or financial assistance.
